When customers purchase RT1 hardware from Omron, Omron will facilitate pre-registration with Secomea Prime. Following pre-registration, Secomea will directly contact the customers to provide the terms, conditions, and pricing for the annual subscription.

New Customers (Registered after (1/15/2025))	New customers are eligible for one complimentary year of the Secomea Prime Essential subscription following their initial purchase of Omron RT100 hardware and pre-registration for Secomea Prime through Omron.
Existing Customers (Registered before (1/15/2025))	Existing customers can continue to use the existing Omron Gatemanager software free of charge until April 1 st , 2026. Customers must enroll with Secomea Prime by April 1 st , 2026, to continue using the RT100 hardware as a remote access solution. Customers can keep using the RT100 with its router functionalities, but without the remote connectivity features.
